#### **Alex Sickel:**

The Report on the Proposed Special Assessments for Public Improvements was presented and approved by the Board. A public hearing will be scheduled and notice will be published as well as sent out to all the residents at Parson's Pasture to give the opportunity for any parties to give public input on the report. After the public hearing the board will meeting and any changes can be made to the report and assessment plan at that time.

The Cost of the project including engineering, administrative and legal costs is estimated to be \$114,197.00. Using the boards authority under its Police Powers the public improvements will be assessed against the properties belonging to the original developer. There are 12 lots belonging to the developer, each lot would be assessed approximately \$9,500. This assessment plan is consistent with the intent of the town and developer and consistent with the increased value conferred to those lots.

Notice will be mailed and published for the public hearing and there will be a special meeting scheduled in October the date will be posted later and each resident will get a notice of the meeting. 10 Days from publication is needed to hold the public hearing. Three different vendors as if the manhole covers can be lower and yes they can. A question was asked what happens if the property doesn't sell and the developer doesn't pay the assessment, after 3 years the county could foreclose on that property and then the town may be able to buy it from the county.
